Faculty Senate Responsibilities to the University

Mike F. Melis University Counsel VCU Office of University Counsel

- He prefers to look at the source documents--did not find a charge for Faculty Senate from bov, state, etc. So he used the by-laws of the faculty, interesting article7 section4 "history language" original approved by BOV 1970 unanimously. Newest version of standing rules approved in 2018. Represent faculty in responsibility and concerns.
- Key participant in shared governance to help vet faculty concerns and presented to president
- Do you see anything in by-laws in conflict with how the university is set up to be run? Nothing was seen at first glance
- Collective bargaining unit similar to faculty senate? State law prevents agencies for working with CBUs. The legislature passed law to allow localities to work with CBU, but not us...
- Recourse if by-laws are not followed? Not clear what the enforcement is. It is different from policy which governs employees/students. Will investigate and get back to us
- Who as the ability to veto by-laws because right now there is no policy or procedure one way or another? Would look first at provost's office for relationship between dean's and faculty. Will investigate and get back to us. Reluctant to interrupt policies but instead focuses on legal matters. His office not the ultimate arbitrator of university policy.
- Anything that FS leadership needs to be aware? Way to try and avoid confusion is to be in close communication with Provost's office.

VCU COVID-19 Dashboard

Thomas Briggs took questions and talked about the concerns about the Dashboard: Assistant Vice President Safety & Risk Management

- Students feel the dashboard is fake? Feedback gotten back, will change next week, 10 days active cases not symptomatic roll off. Have to look at the bottom to see the total number of data. 894 to take a test per month, 220 from resident hall. Finally got student last week by over inviting. By the end of the month should have good data.
- Why not reporting percentage positive tests since only testing symptomatic? Is put not under prevalence but need to put it.
- Free testing on campus for at-will? Can use 250/300 left over from prevalence testing which can be repurposed to provide at-will.
- Concerns with students going elsewhere for testing, maybe the numbers are skewed by students not wanting to report to VCU the results for fear of retaliation? What are we doing to help mitigate those concerns? 13 students for contact tracers are VDH employees, the system we use is the same system that state uses. Employee going to doctor and did not report positive. Takes a bit for VCU to find out, but they always come back to VCU. Chuck Klink working to help communicate about testing.
- Why is the dashboard for Richmond DH and VCU dramatically different? Richmond is testing using PCR only, while VCU uses PCR testing for symptomatic. So not apples to apples data.
- What is the metric for closing? The metric for closing is complicated but involves 3 factors, hospital bed capacity, quarantine/isolation capacity, and percent positive compared to Richmond and surrounding communities.
- Is it more difficult to get a handle on it if we were more isolated campus? Yes it would be much easier. Using data from suburbs as well to get a better picture. The current prevalence test does not have high rigor we use it for timeliness. Nothing really available for other options. Looked at antigen testing, but only tests for RNA fragments. All testing is PCR. Symptomatic is done at VCU and other labs. The response team looks at trends.
- Last comments: We considered all tests available. Looked at type and capacity and turn around. The choice of testing type and group was based on balancing the accuracy of the test with the speed of the test.

Request for Faculty Senators

1) The VCU Safety and Well-being Advisory Committee

is requesting faculty to consider serving on this committee, which has been charged with defining and instituting the components of a new transformational model for public safety and wellness across campus, independent of VCU Police. We seek dedicated candidates who feel compelled to lend us their expertise and are willing to commit to serving as a member from September 2020 to May 2021. Anticipate the committee will meet a minimum of twice a month, concluding after findings are presented to the VCU Board of Visitors and VCU Health System Authority Board of Directors next May. Andrew Daire – dean, school of education and Sheryl Garland, VCU Health System will lead the committee as co-chairs

2) The Domicile Appeals Committee requests a faculty member to serve as a voting committee member on this new committee. This Committee has the final authority at the university for all appeals related to domicile for tuition purposes. The responsibility for this committee has recently transitioned from Student Affairs to Strategic Enrollment Management (SEM). The committee meets once a month. The length of the meetings can range from a couple of hours to closer to four or five hours. It depends on the number of appeals the committee needs to review. Also, the appointment is for a 2-year term, although committee members can be reappointed for multiple terms.

3) The provost's office has asked for a pool of internal reviewers to support academic program review.

VCU internal peer reviewers must be T&R faculty (<u>Academic Program Review</u> <u>Handbook</u>, sec. *4.3.2.1*), and will

- receive a jointly signed letter of recognition from the provost and dean
- gain valuable experience
- make a significant contribution to degree program excellence at VCU

Cohort 1 peer reviews are planned for late February and early March of 2021.
